Political extremist are a threat to the smooth operation of a functioning democracy. I would define an extremist as a person who when they don't get their way will take actions that obstruct or sabotage the function of the systems that they want to control. The actions they may take include deception, intimidation, harassment, or violence.

b. What, if anything, should be done to protect elected officials and the public from those using harassment to stop civil engagement in the exercise of democratic processes?

Stricter penalty for those who break the laws regarding harassment.
